Project Studio Description


in search of SPATIAL NARRATIVES: Design of a City Museum in Karaköy programmatically based on experience

The studio will be formed by a series of design exercises aiming at conducting an inquiry into the role of architecture in creative placemaking. In the first phase of the studio, we will focus on the project area and we will start with deciphering "spatial narratives" with an in-depth exploration of historical layers, spatial relations, networks, daily routines and structures in the city and how people interact with them. In the second phase every student will propose an architectural program with interpreting the idea of a city museum programmatically based on experience considering their explorations in Karaköy and conduct a research on its contextual relations and architectural tectonics.

These questions will represent main discussion and production paths of the studio: How do/can architects understand the intangible qualities and multi-layered realities of a place; how do/can architects imagine and speculate on alternative visions on a place and how do/can architects propose new kinds of architectures against the actual dominance of standardizing, homogenizing character of the spaces of global capitalism?

Discussion sessions on selected readings and a series of research work on architecture culture will be held during studio hours. There will be two workshops; one is about the techniques of Place Literacy and the other on the Experimental Materiality, with the contribution of a group of master students from our faculty. Other activities such as field trips and juries are considered to support ongoing projects during the semester.
