When the environmental and resource crises of today are added to the urban life, it seems compulsory to create new research areas for our happiness. The main subject of the architectural design studio is based on this "happy person / happy city" research. The studio aims to address architectural programs that manage to create fair, safe, healthy, fun... active communities in urban scale.

subject and discussion points.

While we need specific resources to meet our needs and create experiences that make us happy, we have a relative sense of wealth. We usually compare our lives with those of the people around us. If we are in worse status than others, we generally do not feel unhappy... So what is "happiness" for the candidate architects whose main task is to design environments that make people feel happy and well? Among the main discussion topics of the studio, which set out by saying "Let everyone design their own happiness!" and aim to work on possible program components (communication, health, culture, education, transportation ...) that will be used by the citizens as a headline:

:: How can "architecture" respond to this transformation for fair, free, safe and democratic environments that make people feel happy and good, make life easier?

:: What is the "happy city" that is real and is in life, in our daily practice? Even when we look at Istanbul, it seems clear, from how people come together and try to protect their neighborhood, that there is a search. It also contains the potential of it. Therefore, the happy city is a realistic search as much as it is utopian...

:: What does it mean to live happily? Laugh with a hearty laugh? Yes, if a person laughs, there is humanity ... But when this is not just a conceptual question or a situation that involves our own individual concerns, what are the possible functions and program components that make a person feel happy and well?

3. ACTIVITIES

Activities to be carried out within the scope of the Architectural Design studio;

Preliminary Work (Study-1): Preliminary work to be done in the first 3 weeks of the period is a “design exercise in the city axes”.

Term Study (Study-2): It is the main studio work to be carried out throughout the term.

Design Research: Design researches on the study subjects and fields of the semester will be carried out individually or in groups, and presentations will be made by the students in the 3rd– 4th weeks of the semester.

Seminars: Seminars supporting studio work will be given by invited speakers who are experts in their subjects.

4. CONTRIBUTIONS

Throughout the semester, experts and academicians who have experience in the relevant fields will contribute to studio work with supportive seminars or project critics. Seminars on film-making, representation, city narratives will be given by Ali Vatansever, Erenalp Büyüktopçu and Zeynep Günay. The final participation program of the jury members during the semester will be finalized at the beginning of semester.

5. ASSESMENT

Architectural project studio work is a process where high importance is given to active participation. For this reason, class participation throughout the semester and production in the studio will be considered at the evaluation stage. In evaluating the success at the end of the semester:

- active participation and production in studio work throughout the semester,
- design research and presentations,
- participation and performance in the juries throughout the semester,
- project submission

will be taken into consideration. At every stage that is relevant to evaluation, representation and documentation of ideas are as important as the ideas formed. Effective and qualified use of representation tools and systematic documentation of not only the results of the studies but also the processes are among the necessities of the studio. The weights of this general approach for end-of-period success are as follows:

preliminary projects, research presentations, jury evaluations: 40%

evaluation, performance and participation in the process, term project, final delivery: 60%
